JC Glick, a retired Lieutenant Colonel from the US Army, is a decorated military veteran with a distinguished career that includes 11 combat tours, primarily in Special Operations. Known for his leadership and courage on the battlefield, JC brings a different kind of bravery to this talk, one that stems from his personal experience as a survivor of domestic violence. His story is a testament to resilience, to rising above trauma, and to the power of speaking out. His journey from silence to survivorship provides invaluable insight and comfort to others walking similar paths.

Jennifer Glick, a passionate advocate for survivors of domestic violence, brings to the table a wealth of professional knowledge and a relentless drive for justice. She has served as a prosecutor in Nassau County, New York, and honed her legal expertise at the Manhattan District Attorney's office. Jennifer now dedicates her skills to Columbia University Medical School as a Survivor Advocate, providing support and legal guidance to survivors. Her dedication to combating gender based violence and advocating for victims complements the practical, legal view of this societal scourge.

This talk is not just about the individual experience of domestic violence, but also the broader implications. JC and Jennifer will shed light on the often misunderstood and overlooked aspects of domestic violence, challenging societal norms and misconceptions, and empowering others with knowledge and resources.

CHANA: Supporting the Community

As the COVID-19 pandemic has receded and many have returned to a sense of normalcy, victims of abuse continue to suffer innumerable repercussions. Accordingly, CHANA continues to respond to an increase in call volume, and with each call reaching a greater level of danger and complexity than ever before. The consequences of the pandemic pose additional barriers for victims fleeing abusive relationships. Working from home has rendered victims more isolated from social support systems, creating more opportunities for their abusers to abuse and less opportunities to seek help. For victims who are separating from their abusers, initiating legal cases has become more difficult as the courts tackle the backlog of cases that resulted from early-pandemic closures. Simultaneously, there is a greater demand and less availability for pro bono or low bono attorneys. These circumstances render victims more vulnerable and financially unstable as they await divorce, custody and child support hearings and fear outcomes that are not in their favor. The need for social services remains high as the financial instability brought on by the pandemic amplifies economic pressures that contribute to danger in the home. Victims are calling CHANA as they are uncertain how to afford to live without their abuser's financial support as the cost of housing, food, gas and other essentials rises. While they were choosing between the risks posed by their abusers versus the virus three years ago, they now are weighing remaining in an abusive household versus facing housing or food instability. These barriers exist not only for victims of domestic violence, but also elder abuse victims who are often on fixed incomes. For these, and many other reasons, it is anticipated that the need for CHANA's services will continue to grow.
